## Large Commercial (more than 500 Mcf) Variable Rate/ Natural Gas Customer Choice Contract between Bishop Energy Services, LLC, (Supplier) and **(Buyer)**

(Buyer is Account Holder or Legally Authorized Person)

Supplier agrees to sell Buyer natural gas for an initial term beginning with the April, 2016 billing cycle through March 31<sup>st</sup>, 2014. This contract may continue after initial term on a month to month basis, cancelable at anytime. In the event of cancellation during the initial term, Buyer agrees to pay Supplier for all unused gas volumes purchased on the Buyer's behalf less the current market price at time of cancellation. Supplier and Buyer agree to comply with all the requirements, terms and conditions of the program as approved by the Michigan Public Service Commission.

The price of natural gas for the initial contract period will be determined monthly. This *variable rate* will be a monthly cumulative weighted average cost of gas (WACOG) consisting of a supply portfolio of fixed and cash purchases plus all administration fees. Example, Month (1) = 5,000 Mcf @ \$4.95 (\$24,750); Month (2) = 5,900 Mcf @ \$5.35 (\$31,565). The WACOG = \$5.167 ((24,570+31,565)/10,900).

I understand that by signing this contract, I am switching the gas Supplier for this commercial account to Bishop Energy Services, LLC. I understand that gas purchased for this commercial account by Bishop Energy Services, LLC will be delivered through Michigan Consolidated Gas Company's delivery system. The legally authorized person to execute a contract and legally bind the business in this contract has 14 days after today to cancel this contract for any reason through written or verbal notification to Bishop Energy Services, LLC. I may waive this right of cancellation by affirmatively agreeing to this waiver on the contract. If you terminated your contract today, and if the unconditional cancellation period did not apply, based on current gas prices and your historical usage, a good-faith estimate of your termination fee would be calculated as the value of unused gas purchased on Buyer's behalf less the current value of this gas at time of cancellation. This termination fee is subject to change as your usage and the market price of gas fluctuate.**
